

# PRIVACY POLICY

*(Last updated on January 2009)*

Aperture Asia Productions as the controller and processor of the personal information collected through the use of this site is committed in protecting your privacy. In this regard, Aperture Asia Productions has adopted this Privacy Policy which tells you the information we collect online and how we use it.

By using this site, you understand and agree to the terms hereby stated.

## I. Collection of personal information

### a) Personal information collected automatically

When you visit our site, certain information may be collected automatically such as the website that referred you to us, your IP address, information about your browser and access time. We may also collect navigational information such as the pages you view or the actions taken in connection with this site. We may combine your visit and navigational information with personal information you provide to us.

### b) Personal data provided by you

When you register on this site, you must fill in a registration form and provide personal information such as: your name, address, telephone number, fax number, email address, company name and title, username and password. Other additional information will be collected to process any licensing transaction or to provide you with some product or services (ex: credit card number and billing address).

## II. Use of the personal information

The personal data collected by Aperture Asia Productions are for internal use only and more particularly to:

- process orders and issue invoices;
- maintain and update your account;
- send you our products, promotions and advertising;
- send you updates about our new products and services;
- create an activity profile of our site;
- optimize the use of our site

Aperture Asia Productions may use part of your account information to conduct credit inquiries.

### III. Storage of the personal information

The personal data referred to in section I will be kept by age fotostock for as long as required to fulfill the purposes which justified its collection.

### IV. Sharing of the personal information

By providing your personal information to us, you agree that:

-this data may be processed, stored or transferred (whether for free or not) to any affiliate, subsidiary or parent company of Aperture Asia Productions;

-Aperture Asia Productions may share this information with service providers who perform services on its behalf, content providers, necessary payment processors or courier services. These companies will only obtain the personal information they need to deliver the service. They are required to maintain the confidentiality of your information and are prohibited from using it for any other purpose.

-this information may be disclosed as part of any merger, acquisition or sale of the company and/or its assets, as well as in the unlikely event of insolvency, bankruptcy, or receivership, in which the personal information would be transferred as part of business assets of the company.

-this information may be disclosed if required by law or if age fotostock, in good faith, believes that such action is reasonably necessary to comply with legal proceedings, respond to claims, or protect the rights of the company.

Except as specifically set forth in this Privacy Policy, Aperture Asia Productions does not sell, share or rent to third parties any personal information about the users of its site.

### V. Your rights with regards to your personal information collected by Aperture Asia Productions

### VI. Cookies

When you visit our website, Aperture Asia Productions sends a cookie to your computer. A cookie is a small file that resides on your computer's hard drive and contains electronic identifiable information which identifies the user's computer (non-personally identifiable information). Cookies allow Aperture Asia Productions to make its website more useful by storing information about your preferences. For example, cookies will allow you to retrieve previous image search. You can set your browser's options not to accept cookies, but this may prevent you from accessing all of the features of this site.

## VII. Security

The security of your personal information is important to Aperture Asia Productions. In order to protect the confidentiality of your personal information, Aperture Asia Productions has put in place a number of operational functions. For example, when you enter sensitive information (such as credit card information) we encrypt that information using industry standard SSL (Secure Socket Layer). SSL codes the information transferred between you and the server, rendering it unreadable to anyone trying to intercept the information. However, perfect security on the Internet does not exist, and Aperture Asia Productions does not warrant that its website is impenetrable or invulnerable to hackers.
